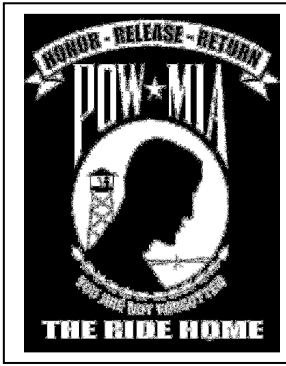

1. U.S.G. formally request the return of all live Americans who are unaccounted for, in captivity or being detained in any foreign country
2. U.S.G. under take all measures necessary to repatriate all Americans who are unaccounted for, in captivity or being detained in any foreign country.
3. U.S.G. under take all measures necessary to obtain all information held and/or known by foreign governments, groups and individuals concerning all Americans who are now or who have been unaccounted for at any time.
4. All information, in any form regardless of when or how obtained, pertaining to Americans unaccounted for prior to 1991 be declassified and made available for public inspection.
5. Funding of all actions to account for Americans who are unaccounted for be fully funded by the U.S.G.
6. All remains recovered in association with unaccounted for Americans, past, present and future, be identified and/or confirmed using the latest scientific means and that all remains be tested and analyzed for age at death using minimal remains to allow for a 2nd, independent DNA analysis if family members so desire.

It is time for Americans to STAND for those who CANNOT STAND for themselves.

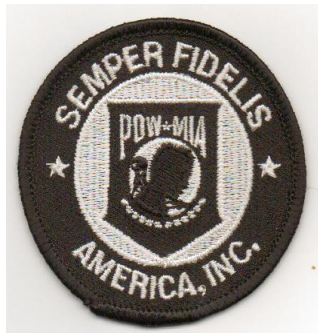

Echo Company is preparing to host the Coalition Mobile Vietnam Replica Wall the first week in December. This will be Greg Walsh's last event before retiring. He will turn over that duty to Doc Russo. They continue to work in getting camping sites for those in The Vietnam Brotherhood who will be assisting in numerous areas such as security, education, maintenance, etc. All the companies from the Vietnam Brotherhood will be on hand to help with Security.

Hotel Company worked several major events already this year and more to come. It all started with the Sam Swope Charity Ride with the Shrines the First Sunday of Bike Week in March. As a result of their efforts they were able to donate \$5,000. to the event that raised \$352,000, all of which goes to the Shriners Children's Hospital in Tampa. They also helped the VVB at the Veterans Reunion by hosting a bar. Besides the rather damp weather which hindered the event Hotel Company was able to donate \$1,550. Toward the event hosted by VVB. Long Term Housing for Paralyzed Veterans:

Working with other agencies we hope to remodel single family homes so they are suited for the special needs of physically handicapped veterans.

Memorial Brick Markers:

Working with the City of Stuart to relocate existing Memorial Brick Markers and provide for new Memorial Brick Markers as part of the remodeled Veterans Memorial Park in The City of Stuart we are expanding the number of memorial brick pavers and providing a lasting tribute to those that have served and sacrificed for their country. THE MEANING OF COINS LEFT ON TOMBSTONES

Have you ever been in a cemetery and saw coins laying upon a tombstone? There is actually a reason behind it. Read more, so you can know what each coin means, and maybe as you visit a fallen soldier you can leave a coin to honor them too. These meanings vary depending on the denomination of coin:

A coin left on a headstone lets the deceased soldier's family know that somebody stopped by to pay their respect. Leaving a penny means you visited.

A nickel means that you and the deceased soldier trained at boot camp together. If you served with the soldier, you leave a dime. A quarter is very significant because it means that you were there when that soldier was killed.

So what happens to the coins after Memorial Day? It is collected and the money is used for cemetery maintenance, the cost of burial for soldiers, or the care for indigent soldiers.

Supposedly the tradition became popular here in the United States during the Vietnam War. It is believed it was a way to show respect without getting into an uncomfortable political discussion about a war that was very controversial.

In general, however, this tradition can be traced to as far back as the Roman Empire. It was a way to give a buddy some spending money for the hereafter.

Two VA Scientists Honored with Awards for Groundbreaking Work on Spinal Cord Injuries

William A. Bauman, M.D., and Ann M. Spungen, Ph.D Awarded 'Sammies'

WASHINGTON – In the past, spinal cord injuries often meant a death sentence for patients – not because of the injury itself, but because of the complications caused as a result of the injury. But thanks to the work of two Veterans Affairs scientists and researchers at the Department of Veterans Affairs (VA), many paralyzed Veterans now have a reason for hope. And a way to live.

Last night, William A. Bauman, M.D., and Ann M. Spungen, Ph.D., Director and Associate Director of VA's Rehabilitation Research & Development National Center of Excellence for the Medical Consequences of Spinal Cord Injury were awarded the prestigious Samuel J. Heyman Science and Environment Medal, also known as the "Sammies."

The Science and Environment Medal is awarded to federal employees who have made a significant contribution to the nation. The pair of VA researchers, who have been working together for a quarter of a century, were recognized in a ceremony in the Andrew Mellon Auditorium in Washington, D.C. VA Secretary Robert McDonald presented Bauman and Spungen their awards.

"Many of our facilities perform groundbreaking work, which serves as a model for healthcare research across the nation," said Secretary McDonald. "I am proud of William and Ann. Any research institution would be proud to have these leading scientists, but they have chosen to dedicate their careers to serving Veterans at VA, and we are proud to call them our own."

In 2001, Bauman and Spungen established the VA's Rehabilitation Research & Development National Center of Excellence for the Medical Consequences of Spinal Cord Injury in Bronx, NY, where Spungen most recently tested a new bionic walking assistance system that enables individuals with paralysis to stand, walk, and climb stairs.

As part of their collaboration, Bauman and Spungen have made great progress in understanding the effects of spinal cord injury on the body. Their work led to the conclusion that persons with spinal cord injury are at a markedly increased risk for heart disease. They were also the first to describe, and then treat, an asthma-like lung condition common in those with higher levels of paralysis. They have developed approaches to make it easier for paralyzed patients to undergo successful colonoscopies. With other researchers in their unit, Bauman and Spungen formulated novel drug combinations to raise low blood pressure, and they have overseen the development of treatments to reduce bone loss shortly after spinal cord injury. Their work has advanced our understanding and treatment of chronic, non-healing pressure

ulcers. Researchers under their direction also are making strides toward improving understanding of body temperature regulation and the effect of swings in body temperature on one's ability to think.

Bauman has worked at the Bronx VA hospital for 35 years, starting in the laboratory of the late Rosalyn Sussman Yalow, VA physicist and Nobel Prize winner. Bauman said he made up his mind from the start to devote himself to patients with spinal cord injury who, at the time, were largely marginalized and overlooked by physicians with training in general medicine.

"I would say our center's greatest accomplishment has been to identify problems in persons with spinal cord injury that no one had appreciated prior to our work, and then to develop successful approaches to solve them," Bauman said. "Prior to our work, many of these problems were not realized to be important, or were ignored because it seemed that nothing could be done to improve them."

Spungen said she can recall being captivated by the sense of civic duty pervading Bauman's energetic sphere of medical research activity at the hospital.

"I got to the VA and met these incredible scientists and investigators who were here working for the Veterans and who were so intelligent, so open, and so kind. I just became enamored with the entire atmosphere and dug in, and I have been here ever since," Spungen said.

Robert Ruff, national director for neurology at the Department of Veterans Affairs, said the work of Bauman and Spungen has had a wide-ranging impact. "The research is relevant not only to people with spinal cord injury, but to a larger population who are immobilized, from those with ALS to cancers, muscular dystrophy, multiple sclerosis, dementia or Parkinson's disease," Ruff added.

The Service to America Medals are presented by the [Partnership for Public Service](#). This year, eight award winners were chosen from 33 finalists and almost 400 nominees. The 2014 selection committee included CEO Alberto Ibarguen of the Knight Foundation, Maryland Senator Benjamin Cardin, and Georgetown University President John DeGioia

VA Updates Disability Claims Application New Process Will Reduce Processing Times and Improve Quality

The Department of Veterans Affairs (VA) today announced that it is introducing a uniformed disability claims form to better serve Veterans, families and survivors. Standardizing the process by which Veterans file claims and initiate appeals will make it easier for Veterans and their survivors to clearly state what benefits they are seeking from VA and provide information that is necessary to process their claims and appeals. The new forms eliminate applicant guesswork, which often leads to delays in decisions and ultimately delays in receiving benefits. The new regulations go into effect in late March 2015.

"We must do everything that we can to make it as fast and easy as possible for Veterans and their survivors to file for and receive an accurate decision on their claim," said VA Secretary Robert McDonald. "Our Veterans and survivors will know, at the outset of the claims process, what is needed, which removes subjective interpretation from the process. We want to eliminate any barriers that make it difficult for our Veterans or survivors to receive benefits to which they are entitled." In the past, a Veteran or survivor did not have to use a certain

form to seek compensation or other benefits from VA. Claims or appeals (Notice of Disagreement) could be submitted on any piece of paper which caused delays due to missing information.

By using standard forms for all disability claims, VA can more quickly and accurately identify what the Veteran is claiming or appealing. This will allow VA to immediately move on to next steps in the evidence-gathering and decision-making process, which saves administrative processing time and speeds the delivery of earned benefits. The existing process is also inconsistent with most, if not all, other government and non-government application processes, such as applying for social security, applying for a driver's license, applying for a job or filing for an income tax refund. "These days, government agencies and private businesses rely on standard forms to deliver faster and more accurate customer service," said Under Secretary for Benefits Allison A. Hickey. "VA's ability to deliver better customer service requires the use of standard forms as well. That is why we worked extensively with our partners in the Veterans community to streamline the way we process claims while preserving the effective date rules concerning informal claims through the creation of a new *intent to file a claim* process." The updated process also includes standardizing the traditional informal claims process by employing a new "Intent to File a Claim" process which affords the Veteran or survivor one year to compile the necessary documentation or evidence to support the claim while preserving an effective date of claim. St. Lucie County Chosen as Site of Seventh State Veterans' Nursing Home

TALLAHASSEE (Sept. 23) -- St. Lucie County will host the site of the next state veterans' nursing home, following a unanimous vote in today's Cabinet Meeting at the Capitol.

The decision was made following a presentation on the site selection process by Florida Department of Veterans' Affairs Executive Director Mike Prendergast.

The site in St. Lucie County was one of nine locations in six counties visited in June 2014 by a site selection committee composed of representatives from Florida's veteran community, the Florida Department of Veterans' Affairs and Florida Department of Management Services, which will oversee construction of the new 120-bed skilled nursing facility. The visits were publicly noticed and attended by local officials and members of the community.

Following public deliberation, the committee selected St. Lucie County as its top recommendation during a July 1 vote and forwarded the recommendation to the FDVA executive director for consideration.

Today's recommendation followed a months-long deliberative process, following Prendergast's Feb. 7, 2014 Cabinet Meeting presentation, which discussed the need for and formal process necessary to build additional veterans' nursing homes in Florida.

His presentation was based on an independent study authorized by the 2013 Florida Legislative Session and signed into law by the governor, which identified ten counties having the greatest need of a state veterans' nursing home. Six of the counties submitted formal proposals in May 2014 to the Florida Department of Veterans' Affairs for consideration.

"I greatly appreciate the time and due diligence each member of the site selection committee made in reviewing the individual proposals and inspecting the nine sites," said Prendergast. "Their recommendation reflected a thoughtful and deliberative process which reflected a host of issues surrounding the suitability of the land offered by the six counties."

The overall planning and construction of new veterans' homes is a multi-year process dependent upon both federal and state matching funds.

"There are more than 700,000 veterans in the Sunshine State who are 65 years of age or older," said Prendergast. "The need to build additional skilled nursing facilities has already been established and we look forward to building additional facilities in the coming years."

The state's network of existing veterans' nursing homes has an occupancy rate averaging 99 percent. Florida currently has state veterans' nursing homes in Daytona Beach, Land O' Lakes, Panama City, Pembroke Pines, Port Charlotte and St. Augustine. The department also operates a veterans' assisted living facility in Lake City.

The Florida Department of Veterans' Affairs, serving the nation's third largest veterans' population, celebrates its 25th Anniversary in 2014.

Payment or Reimbursement for Certain Medical Expenses for Camp Lejeune Family Members

The Department of Veterans Affairs (VA) is committed to providing the best care for Veterans and families related to Camp Lejeune historical drinking water contamination as required by law. VA is announcing the publication of two regulations: one providing health care for Camp Lejeune Veterans and the other reimbursing for health care expenses of their family members potentially affected by contaminated drinking water at U.S. Marine Corps Base Camp Lejeune, North Carolina. The regulations implement provisions of the "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012."

The first regulation, entitled *Hospital Care and Medical Services for Camp Lejeune Veterans (AO78)*, will take effect immediately. The second -- *Payment or Reimbursement for Certain Medical Expenses for Camp Lejeune Family Members (AO79)* -- will take effect 30 days after publication.

The published regulations now allow VA to reimburse eligible Camp Lejeune family members for out-of-pocket health care costs related to any of the 15 covered medical conditions listed in the 2012 Act. Under that law, VA can reimburse costs from March 26, 2013, onwards. Family members can start applying 30 days after the regulation publication date. Since the passage of "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012", VA has enrolled and provided health care to those Veterans who served on active duty at Camp Lejeune for at least 30 days between January 1, 1957 and December 31, 1987.

Background:

President Obama signed the Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012 into law on Monday, August 6, 2012. In compliance with the law, VA provides

health care to Veterans stationed at Camp Lejeune in North Carolina between 1957 and 1987 and meeting certain criteria. In late 2014, VA will begin reimbursement of health care expenses to their affected family members.

From 1957 to 1987, people living or working at Camp Lejeune were potentially exposed to drinking water contaminated with chemicals known as volatile compounds, including industrial solvents and benzene from fuels. The law provides that Veterans stationed at Camp Lejeune between 1957 and 1987 will be eligible to receive health care through VA, and exposed family members will be reimbursed for health care costs, for the following medical conditions

1. Esophageal cancer;
2. Lung cancer;
3. Breast cancer;
4. Bladder cancer;
5. Kidney cancer;
6. Leukemia;
7. Multiple myeloma;
8. Myelodysplastic syndromes,
9. Renal toxicity;
10. Hepatitis steatosis;
11. Female infertility;
12. Miscarriage;
13. Scleroderma;
14. Neurobehavioral effects; and
15. Non-Hodgkin's Lymphoma.

For family members, VA will be the last payer and will provide reimbursement after all other health insurance coverage and reimbursement is received, as required by law.

Frequently Asked Questions:

Q: Who is eligible for the Camp Lejeune program?

A: Veterans may be eligible for Camp Lejeune coverage if they meet the following criteria:

- Served on active duty at Camp Lejeune for no less than 30 days between January 1, 1957 and December 31, 1987
- Meet all the qualifications for VA benefits, including meeting the VA definition of "Veteran," and receiving a discharge other than dishonorable

Additional qualifications can be determined by completing the 10-10EZ form and enrolling in VA benefits.

Family members may be eligible for the program if they resided on Camp Lejeune as a dependent of an Active Duty Servicemember, or were in utero, for no less than 30 days between January 1, 1957 and December 31, 1987 and have one of the illnesses or conditions listed in the law. VA may reimburse costs associated with hospital care and medical services, as the last payer, for the eligible family members for the 15 illnesses or conditions. Once those family members have submitted claims to their insurance

companies, they can apply to VA for reimbursement of the remaining balance of charges and fees connected to the qualifying illnesses

Q: How do Veterans and family members apply for the Camp Lejeune program?

A: For Veterans: Veterans seeking to enroll in VA health benefits can enroll online at www.va.gov/healthbenefits/apply or at their local VA Health facility (www.va.gov/directory). Veterans seeking more information about VA's Camp Lejeune Program or to apply via phone can call **1-877-222-VETS (8387)**.

Veterans should locate relevant documentation to show proof of Camp Lejeune residency of not less than 30 days (e.g., copies of orders, base housing records, medical or school records, etc.). This information will be utilized by the Veteran Health Administration to validate eligibility for care under this authority.

For family members: Once the family member regulation is effective (30 days after it is published), interested family members will be able to apply online. Submitted applications and supporting documentation will be reviewed to determine family member eligibility for the program.

Once deemed eligible for the program, family members who have received care for one of the 15 Camp Lejeune conditions since March 26, 2013, can submit a claim for reimbursement. Family members should keep receipts for medical expenses related to the covered illnesses/conditions. Because the Camp Lejeune law only reimburses expenses, as the payer of last resort, related to the 15 conditions, family members should not change their existing health insurance.

Family members who have questions regarding applying for Camp Lejeune Family Member Program benefits, claims payment, appeals, or other related matters should call toll-free at **1-866-372-1144** between the hours of 7 to 4:30pm CST.

Q: Is the reimbursement for care retroactive?

A: No, reimbursement is only from the point in time the Veteran enrolls in VA, if after 8/6/12 or reimbursement of VA copayments back to 8/6/12, if already enrolled and identified as a Camp Lejeune member within 2 years of publication of the rule. VA began providing Veteran care for Camp Lejeune on 8/6/12, following the passage of "Honoring America's Veterans and Caring for Camp Lejeune Families Act of 2012".

Q: Does this law provide Veterans with disability compensation?

A: No. This law allows Camp Lejeune Veterans to enroll in VA health care. It does not provide service connection and compensation.

Veterans who believe they have an injury/illness related to their military service may file a claim for disability (adjudication) for their condition at their Department of Veterans Affairs Regional Office. Vietnam PTSD Discharges DoD Has Agreed to Reconsider

The Defense Department has agreed to reconsider the bad-paper discharges for thousands of Vietnam-era veterans who may have suffered from combat-related post-traumatic stress disorder but were kicked out of the military in the era before that became a diagnosable condition. In a new rule announced 3 SEP, the Pentagon said veterans from the Vietnam era and other past wars with other-than-honorable discharges will be given "liberal consideration" if they seek to correct their military records and provide some evidence of a PTSD diagnosis that existed at the time of their service. Upgraded discharges could result in the restoration of some benefits, such as disability pay, separation pay or GI Bill benefits from the Veterans Affairs Department, which are typically denied to vets who receive other-than-honorable discharges. Health care in the VA system is typically provided to veterans regardless of their discharge.

In today's military, PTSD is considered a mitigating factor for misconduct and behavioral problems. The military services are required to grant a medical evaluation to any service member who claims PTSD before finalizing a bad discharge. The Pentagon's new rule comes in response to a federal lawsuit filed on behalf of several veterans in March that claimed the Defense

Department was wrongfully denying discharge upgrade applications from veterans with claims and evidence of PTSD. The new policy was applauded by the Yale Law School Veterans' Legal Service Clinic, which is spearheading the federal McTiernan, a student intern involved with the lawsuit. However, she said, it's too early to tell how the new rule will be.

VA Accountability

Legislation to Punish VA Employees

When Congress last month passed a massive overhaul and funding initiative to fix the broken Veterans Affairs Department, the law's architects said their work was just getting started. On 10 SEP, members of the House Veterans' Affairs Committee followed through on that promise. Lawmakers approved yet another measure that would make it easier to fire the agency's senior executives and take away their bonuses both proactively and retroactively. The Comprehensive Department of Veterans Affairs Performance Management and Accountability Reform Act, sponsored by committee Ranking Member Mike Michaud (D-ME) aims to set clearer goals against which senior VA executives' job performance could be measured. The legislation would:

- Establish up-front organizational goals for the agency's senior executives, and use them in reviewing performance.
- Require that any Senior Executive Service employee who receives a rating of less than "fully successful" in consecutive years be removed from the SES.
- Requires doctors or dentists who do not receive a successful review would not be eligible to receive performance pay. VA medical staff receive a base salary, and typically also receive a percentage of that salary as a bonus, based on their performance rating.

Another bill sent to the House floor was a measure -- introduced by the committee's Chairman Jeff Miller (R-FL) -- to recoup bonuses already paid to employees later found guilty of misconduct. The legislation does not spell out specific criteria that would qualify an employee for the retroactive penalty, leaving that to the VA secretary's discretion. The employee would have to be given notice and the opportunity for a hearing. A similar measure (<http://www.govexec.com/pay-benefits/2014/07/senators-want-va-wait-list-manipulators-give-back-their-bonuses/88165/>) which specifically targets bonuses given to employees found guilty of manipulating patient wait list data, was introduced in the Senate with bipartisan support.

Former VA Secretary Eric Shinseki in May rescinded an \$8,500 performance award given in 2013 to Sharon Helman, who served as director of the Phoenix VA hospital at the epicenter of the recent scandal. VA said that bonus, however, was originally awarded due to "administrative error." Federal employee advocates and the VA itself have since questioned the agency's authority to rescind a bonus for malfeasance, hence the push for legislation. The compromise bill President Obama signed into law in August expedited the process for firing or demoting senior executives at VA. It did not address employee bonuses, though before resigning Shinseki prohibited any performance awards for

Veterans Health Administration's SES employees in 2014. The Merit Systems Protection Board, which saw its ability to reverse a negative personnel action diminished by the August VA reform law, has said the firing provision [raises due process concerns](http://www.govexec.com/management/2014/08/federal-appeals-board-has-major-concerns-firing-provisions-new-va-law/90887/) (<http://www.govexec.com/management/2014/08/federal-appeals-board-has-major-concerns-firing-provisions-new-va-law/90887/>) and has written to the White House to air its grievances. American Veterans Disabled for Life Memorial Dedicated October 5, 2014

Throughout our nation's history, service men and women have gone bravely into battle, risking their lives and livelihoods, sacrificing their safety to defend America. When their duty is done, many return home to life as it was. Sadly, for over 4 million veterans seriously injured in the line of duty, leaving the battlefield does not mark the end of conflict. These permanently disabled heroes often carry home life-altering disabilities -- stern reminders of the price of freedom.

America's disabled veterans have honored us with their service and selfless duty. It is now our turn to honor them.

For the first time, America will pay tribute to some of our most courageous heroes -- our disabled veterans. The American Veterans Disabled for Life Memorial will celebrate those men and women who may be broken in body -- but never in spirit.

Our nation's wounded warriors need time to heal; and the rest of us need a place in which to reflect upon their sacrifice. Here's David Martin: It's a thing of beauty designed to honor an ugly fact: the wounds of war. The name of Washington's newest memorial - American Veterans Disabled for Life -- makes the point.

Project director Barry Owenby gave Martin an advance look at the memorial, which opens next Sunday. It's for disabled veterans of all wars, of whom an estimated three million are alive today.

"It doesn't end with the war; they live with it forever," Owenby said.

"They have a trauma of injury, a healing process, and then their rediscovery of purpose. So that's the story that we're trying to tell here."

It's the story of soldiers like Bob Dole, who came back from his World War II wounds to become a United States Senator and run for President: "It's faith that gives you the strength to endure," Dole wrote, "faith that won't allow you to give up, faith that manifests itself in a ferocious determination to take the next step -- the one that everyone else says is impossible."

They are also stories of disabled veterans you've never heard of.

Joe Bacani was shot through the pelvis by a sniper in Iraq in 2007. His story is on the monument's wall next to Bob Dole's.

Martin said to Bacani, "It doesn't matter if you're famous. It's what you've been through. So you probably earned it as much as Bob Dole did."

"Oh. That's humbling," he replied. "Because I, I've always seen myself as just, like, a normal average Joe."

A picture on the wall shows Bacani in a wheelchair, taken at his Purple Heart ceremony at Walter Reed. "Average Joe" Bacani is now a junior at Columbia University.

"I was never really ambitious," he said.

"Here you are getting an education at one of the top colleges in America!" said Martin.

"Yeah," he laughed. "So after I was wounded, I saw that as, like, a second chance, and I wanted to make the most out of it, especially for my friends' sacrifices. Like, I want to be the best I can be until I die."

The Memorial is located at the foot of Capitol Hill.

**Dr. Benishek Authors Legislation To Research
Toxic Exposure for Military Families
Dr. Dan Benishek announces the Toxic
Exposure Research Act, H.R. 5484**

WASHINGTON, DC: Dr. Dan Benishek (MI-01) today announced he has introduced the Toxic Exposure Research Act, H.R. 5484, with Congressman Mike Honda (CA-17) to establish within the Department of Veterans Affairs (VA) a national center for research into the health conditions experienced by the descendants of veterans exposed to toxic substances.

"Having had the opportunity to treat our veterans as a doctor at a VA hospital for nearly 20 years, I understand that not all the injuries our returning service members suffer from are immediately evident. Wounds from exposure to toxic chemicals can have lifelong and generational effects, the impacts of which we are still determining today," said Dr. Benishek. "This bipartisan bill will help address the need to better understand the toxins that many of our heroes have been exposed to, and ensure we focus on understanding the effect exposure may have on their descendants." The Toxic Exposure Research Act will allow the VA to research the effect of exposure to toxic substances on the descendants of our veterans. Veterans seeking care for symptoms of toxic exposure are frequently misdiagnosed due to a lack of scientific understanding, and the research the VA has conducted on suspected birth defects related to toxic exposure is severely limited. The bill would also create a national outreach campaign on potential long-term health effects of exposure to toxic substances by members of the Armed Forces and their descendants. "The Toxic Exposure Research Act is an important piece of bi-partisan legislation that will help us keep our promise to our veterans. While we know that our servicemen and women have been exposed to toxic substances while fighting for our country, we also know that many of their children have consequently suffered with various forms of birth defects," said Congressman Honda. "We need to know the full effects of such toxic exposures. Through the bill's establishment of a national research center, the VA can determine what effect toxins like Agent Orange have had on the children and grandchildren of our veterans who were exposed. The Toxic Exposure Research act is the House companion to S.2738, identical legislation

introduced by Senator Richard Blumenthal (CT) and Senator Jerry Moran (KS). The legislation is supported by the Vietnam Veterans of America (VVA) and AMVETS. Dr. Benishek has been a leader in advocating for reform at the VA since coming to Washington in 2011. Dr. Benishek spent 20 years working as a surgeon at the Iron Mountain VA Hospital. He is the only member from Michigan on the Veterans Committee and is Chairman of the Health Subcommittee. His "Demanding Accountability for Veterans Act" passed

To fulfill its mission, Wreaths Across America seeks to significantly expand sponsorships and wreath donations by mid-November.



Wreaths Across America is a non-profit organization founded in 2007 by the Worcester family, owners of the Worcester Wreath Company in Harrington, Maine. The wreath-laying effort began with a simple act of patriotism when co-owner of the Worcester Wreath Company, Morrill Worcester, donated 5,000 evergreen wreaths to Arlington National Cemetery in 1992. Today, the annual pilgrimage from Maine to Arlington National Cemetery is known as the world's largest veteran's parade with 50 long-haul tractor trailers from major sponsors making the week-long journey. "It is our great honor to place a holiday wreath on every head stone at Arlington to ensure that all of those buried on this hallowed

ground are uniquely acknowledged and remembered for sacrificing their lives to protect our freedoms," said Karen Worcester, executive director, Wreaths Across America. "For this reason, we are committed to coordinating this parade, creating and distributing the wreaths and securing the logistical support necessary to successfully execute an event of this scale. Our hope is that veterans across the country will view this event as a symbol of the American people's profound appreciation."

The parade will stop at schools, monuments, veterans' homes and communities along the way to remind people how important it is to remember, honor and teach — in keeping with the organization's mission to teach younger generations about the value of their freedom and the importance of honoring those who sacrificed so much to protect those freedoms.

This year, including the effort at Arlington, Wreaths Across America will distribute 400,000 wreaths nationwide, providing support for memorials in all 50 states, including special services at Valley Forge Military Academy, Pearl Harbor, Bunker Hill, Charleston Naval Shipyard, and a wreath for every victim of 9-11 in New York City, the Pentagon and Shanksville, Pa.

At 11:00 a.m. there will be a wreath laying at President Kennedy's grave followed by an 11:30 a.m. wreath laying at the USS Maine Mast Memorial. The final ceremony will take place at the Tomb of the Unknown Soldiers at noon.

While the Arlington Cemetery stop on the Blue Line stops at the cemetery entrance, you can access various parts of the Cemetery from the Rosslyn, Pentagon, and Pentagon City stops via only a short walk. 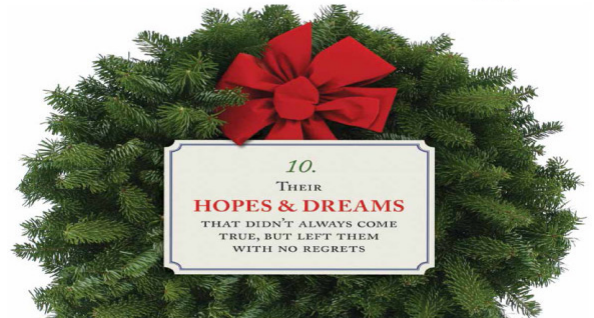

Military Addressing Tips

Make sure your mail reaches our troops

Our troops look forward to receiving your letters and packages. That's why it's important to make sure your mail gets there, to the right person, in the right place.

The Department of Defense has issued the following guidelines for addressing your mail to military and civilian personnel deployed overseas

1. **Use the service member's full name.** The Department of Defense cancelled the [Any Service Member program](#) so mail must be addressed to someone specific.
2. **Include the unit and APO/FPO/DPO** (Air/Army Post Office or Fleet Post Office) address with the nine-digit ZIP Code™ (if one is assigned). [Click-N-Ship®](#) customers should be advised that the Postal Service and the Military will continue to add and update valid APO/FPO addresses for your online labels.
3. **Include a return address.**
4. **For packages, print on one side only** with the recipient's address in the lower right portion or print a postage-paid label online with [Click-N-Ship®](#). (Please note that ZIP Codes 093XX and 964XX are currently unavailable for electronic labels)

What special precautions should I use when packaging overseas military mail?

Following these precautions will safeguard your package on the way to its final destination:

- 1 Place the mailing address inside the parcel on a separate piece of paper.
- 2 Use a box that is constructed to conform to the contents you are sending.
- 3 Ensure the weight of the items in the box is evenly distributed.
- 4 Add packing material on the inside if any portion of the box sags or is easily depressed.
- 5 Use packaging tape for wrapping the outside of the box. Do not wrap with string.
- 6 Cross out or cover excess markings or printing to prevent your box from being misssent.
- 7 Enclose all personal hygiene items, such as deodorant, lotion, or shampoo, in a sealable bag.
- 8 Place all perishable items, such as cookies, chips, etc., in a plastic container.
- 9 Do not mail liquids of any kind, especially carbonated drinks, which can explode during transit.

Military Care Package Mailing Kit

Since Priority Mail service supplies are the packaging of choice for families preparing care packages for service members overseas, the USPS has created a "Mili-kit" based on the items most frequently requested by the **military**.

The kit contains:

- Three (3) each of flat rate boxes O-FRB1 and O-FRB2
- Two (2) each of Cube boxes OBOX7
- Address labels - Label # 228: 8 each
- Address labels - Label # 106-A: 1 each
- Customs FORM 2976-A: 8 EA.
- Customs FORM Envelope 2976-E: 8 EA.

To order the kit, call 800-610-8734. Guidelines for packing, addressing, and shipping items to U.S. troops can be found at usps.com/ship/apo-fpo-guidelines.htm. [Click here](#) to order flat-rate boxes featuring the "America Supports You" logo.

1. Choose your language ("1" is English, "2" is Spanish).
2. Choose option 1 (it states it is for Express Mail service, Priority Mail or Global Express Guaranteed).
3. When you reach a live agent, request "**CAREKIT04**."
4. Please allow 7-10 days for delivery.

Note: These are free supplies, postage must be affixed.
