By-Law Amendment

The by-law change for Section 7.2 was approved and now reads as follows: "All Officers and Directors must be registered regular members. To serve in the office of President, or Vice President you shall be a veteran who served in a military organization, and received an honorable discharge as shown on their DD Form 214. All Officers claiming veteran status must hold an honorable discharge with a DD 214 on file."

Brevard County Veterans Court

The BCVC Committee continues to meet monthly to formulate the plan of moving forward with the program. The projected start-up date is set for mid-January.

The BCVC is currently seeking volunteer mentors to assist our veterans as they are processed through the legal system.

Volunteer Veteran Mentors are a key component to Veterans Courts. Shared war and combat experiences create an enduring and therapeutic trust that can be a stronger bond among returning veterans than in some cases with families and friends.

The volunteer mentor develops a supportive relationship with the



Veterans Court participant, acting as an advocate and ally. The volunteer mentor coaches, guides, acts as a role model, assists participants with accessing health and social service support from the VA and re-entry into civilian life. There are no hard and fast rules. The volunteer mentors may help with readjustment issues such as anger management, impulse control, conflict resolution skills and other issues that create a difficult re-entry into civilian life. There are no hard and fast rules.

In Veterans Court, volunteer mentors may assist the Veteran to navigate through the Court, treatment, and the Department of Veteran's Affairs system, but they do not assume the role of attorneys or treatment providers.

Veterans Transitional Facility

The function of the transitional facility is to take in homeless veterans and help them to re-engage with society. Veterans (and their spouses and children) are provided with housing, clothing, food, and transportation to the VA for appointments. We also provide assistance to veterans within our community.

Candidates are placed in touch with our facility via the community who come into contact with veterans in need, such as: the VA Administration, hospitals, Daily Bread, the temporary housing facility in Melbourne, to name a few. The veteran is interviewed by the VA Admin Grant Per-Diem coordinator and the transitional facility manager to see if the veteran in-need and the facility will be a good fit. The average length of housing is 90 days.

The candidate must be alcohol and illicit drug-free at the time of placement, and continue to be free of substance abuse during the length of stay at the facility. Random testing will take place throughout the stay.

Goals are set with the candidate that will be met during the stay at the facility. Case management continues during the length of stay, helping to achieve goals and to find employment, as well as looking into vocational rehabilitation. There have been successes with employment thanks to vocational rehabilitation.

To provide aid to economically, emotionally, and culturally deprived persons and groups through education, sports, and motivational programs.



To study on a nonpartisan basis proposed legislation or rules and regulations introduced in any federal, state, or local legislative or administrative body which may affect the social, economic, educational or physical welfare of Vietnam and all Veterans, and develop policy proposals designed to address the value of such proposed legislation.

To conduct and publish research on a nonpartisan basis, pertaining to the relationship between all Veterans and the American society, the Combat experience, and the role of the United States in securing a peaceful coexistence in the world community

To engage in all other activities which are related to the foregoing purposes provided, however, that the corporation shall have no purpose and shall exercise no power which would prevent it from qualifying as an organization described in 501(c)(3) of the Internal Revenue Code of 1954 as exempt from taxation under Section 501(a), and to which contributions and gifts may be made which would entitle the donor to the allowance of a deduction under the provisions of Section 170 of said Internal Revenue Code.





3.6% COLA for 2012

The Cost of Living Adjustment (COLA) for 2012 will be 3.6% for military retired pay, Social Security benefits, and VA disability compensation. This is the first COLA increase since 2009.

Gulf War, Iraq/Afghanistan War Presumptive Conditions

The VA has proposed a regulation change that names nine conditions or diseases as "presumptive" due to service in the Persian Gulf War, and for the first time, the current wars in Iraq and Afghanistan.

Presumptive status means that veterans with such conditions only need show that they served in the conflicts/areas included for their condition to be deemed service-connected. The nine conditions/ diseases are malaria, West Nile Virus, brucellosis, campylobacter jejuni, coxiella burnetii, mycobacterium tuberculosis, nontyphoid salmonella, shigella and visceral leishmaniasis.

This year's 17th Operation Stand Down will be held on Saturday, March 24th at the Cocoa Armory from 8 am till 2 pm. This event helps our homeless veterans in the county by providing health assistance, clothing, hair cuts, camping supplies, legal assistance, VA assistance, transportation and much more.

We really need your help setting up for this event. On Friday March 23rd our supplies for the event are moved from our storage unit near the Veterans' Memorial Center to the armory and we set up for the event. We meet at 0900 at the VMC and finish about 1400. On Saturday we will process about 200 or more homeless vets and in some cases their families. We start at 0800 until about 1400.
